Consignment Sellers Agreement

This Consignment Sellers Agreement is between the legal owner of the goods to be sold, the "Owner" and RE/SELLR acting as the "Selling Agent". *Selling Agents are not employees, consultants, or independent contractors of eBay Inc, Vestiare, Vinted* or any other online platform that may be used from time to time.

By engaging the services of Re/Sellr, the Owner agrees to all terms and conditions and fully understands the consignment services as offered by the Selling Agent.

The Owner agrees to allow the Selling Agent to sell the item(s) online and understands payment will be issued once the buyer pays, receives the item and leaves feedback for the Selling Agent or 30 days have lapsed from the date of shipping.

I understand it is against the law to sell fake goods:

- a) If in the course of appraising an item for listing it is found not to be authentic the Owner will receive notification to collect it within 10 working days. If not collected on the 11th day the item will be destroyed.
- b) If an item is found not to be authentic after a sale completes, the Owner must pay an administration fee of £25 and will not be eligible for consignment commission. Any possible related fees to this case will be deducted from the owner. The owner will not receive the item back.

The Owner agrees that they have truthfully and accurately described the condition and all relevant information to the Selling Agent and understands that flaws, stains or defects will be described on the sales listing and may result in a lower sale price.

The Owner confirms they are the legal owner of the consignment items and/or have permission/legal right to sell consignment items.

The Owner understands that if the Selling Agent receives a bid at or above the agreed opening bid price (or at or above the reserve price), they are obliged to complete the transaction with the highest bidder upon the auction's completion, unless there is an exceptional circumstance, such as: (a) the buyer fails to meet the terms of listing or (b) buyer's identity cannot be authenticated then the Selling Agent may choose to not sell to this Buyer.

The Owner acknowledges that shill bidding is not permitted. They will not, nor will they have another party bid on their item(s) in order to artificially raise the level of bidding or price of

that item. The Owner understands that this type of bidding is not only against eBay policy but is also against the law (Fraud Act). Shill bidding will result in a Stop Auction Fee of £25.00 per item. Further, the Owner is aware that during the course of the sale there may be questions about their items from prospective buyers for which they are obliged to respond to the Selling Agent within 24 hours. Failure to respond in a timely manner may result in a lower final sale price.

When requested by the Selling Agent, the Owner agrees to pick up any unsold items within 10 days of notice being sent, (phone, text or email notice). After 11 days, unsold items that are not picked up will be considered abandoned property and auctioned off to cover storage and sale expenses. The Owner agrees to surrender all ownership rights of the consigned item with no additional authorization from the Owner.

The services provided under this agreement are provided as is and without warranty. RE/SELLR is not liable for any damages that may arise from or in connection with this agreement, the performance of this agreement or the consignment of your items. This is the complete agreement of the parties. There are no oral terms.
